Children's Opportunity Alliance: *Grant Recipient*

The Children's Opportunity Alliance (formerly the Children's Opportunity Fund) selected Wonders Professional Development Consortium (PDC) to receive a grant for the 22-23 school year. The grant will enable Wonders PDC to offer professional development workshops in equity focused early childhood education. Wonders PDC will also support ECE educators, specifically Black and Brown educators, in reaching qualified status to independently develop and lead ECE workshops. Leading for Children: *Equity in Early Learning*

Earlier this spring, Wonders program directors and leaders participated in a study group in partnership with Leading for Children. Meeting over several weeks, participants used the reflective practice journal, *The Five Commitments of Optimistic Leaders for Children*. The work is designed to support educators as they strengthen their roles as leaders in the field to advance collaborative, equitable learning environments for young children. We hope to expand this opportunity to more members of the Wonders community this year. This learning opportunity was made possible through a gift from the Crispell-Weinstein family to increase professional development opportunities for Wonders educators on topics of social-justice and anti-biased education.

Story Tapestries: *Arts Collaborative*

Wonders early learning centers are partnering, for the third consectutive year, with the Story Tapestries Ensemble (STE) in a 5-session residency to bring arts-centered learning into the classrooms. Art education positively impacts children academically, socially, emotionally and artistically. Through this partnership, children and their families will have the chance to engage in a range of theatre and storytelling performances aligned with MSDE fine arts standards and Enlgish Language Arts standards of learn. Second Step:

K - Grade 5 Curriculum

Wonders extended day educators will be using web-based trainings and classroom toolkits to implement the Second Step Curriculum in all nine of our extended day programs. Second Step is a research-based, social-emotional learning (SEL) curriculum designed to help social-emotional skills like community-building, empathy and kindness, and growth mindset to children from Kindergarten through Grade 5. Children Discovering Thier World: Pre-K Curriculum

Wonders early learning centers are a recipient of a MSDE grant to provide ECE educators coaching and materials to effectively implement the Children Discovering Their World curriculum for preschoolers and preK. Children Discovering Their World (CDW) is a comprehensive curriculum developed by the University of Maryland in partnership with the Smithsonian, that is fully aligned with MSDE's Early Learning Standards and their Kindergarten Readiness Assessment. CDW is organized around project-based inquiry and provides daily math and literacy small group experiences. Learn More.
