FAMILIES PAY \$30 APPLICATION FEE AND \$70 ANNUAL REGISTRATION FEE PER CHILD

A 10% DISCOUNT APPLIES TO THE TOTAL MONTHLY TUITION FOR TWO OR MORE SCHOOL AGE CHILDREN IN THE SAME HOUSEHOLD.

TUITION IS CALCULATED FOR THE SCHOOL YEAR PROGRAM AND BILLED IN TEN EQUAL MONTHLY PAYMENTS.

TUITION IS THE SAME EVERY MONTH REGARDLESS OF THE NUMBER OF PROGRAM DAYS IN EACH MONTH.

EACH PAYMENT COVERS APPROXIMATELY 4.2 CALENDAR WEEKS.

TUITION IS EXCLUDING DROP-IN FEES. DROP-IN FEES INCURRED ARE BILLED THE FOLLOWING MONTH.

THE FIRST PAYMENT IS DUE AUGUST 15TH AND THE FINAL PAYMENT IS DUE MAY 15TH. NO PAYMENT DUE IN JUNE.

A DEPOSIT MAY BE REQUIRED FOR THE ACCOUNTS NOT SET UP ON AUTOMATIC PAYMENT.

THERE IS A PROCESSING FEE ON DEBIT OR CREDIT CARD PAYMENTS.
