#### ENROLLMENT FEES PER CHILD

NEW FAMILIES PAY \$30 APPLICATION FEE AND \$80 ANNUAL REGISTRATION FEE.
RETURNING FAMILIES PAY \$80 ANNUAL REGISTRATION FEE.

FAMILIES PAY \$70 REGISTRATION FEE, IF ENROLLED BY MAY 15, 2025.

TUITION IS DUE ON THE FIRST DAY OF ENROLLMENT AND SUBSEQUENTLY ON THE 10TH DAY OF EVERY MONTH. THE FIRST PAYMENT FOR THE NEW SCHOOL YEAR IS DUE ON AUGUST 10, 2025.

A 5% discount applies to the total monthly tuition for two or more school age children in the same household.

Tuition is calculated for the school year program and billed in ten equal monthly payments.

Tuition is the same every month regardless of the number of program days in each month.

Tuition is excluding drop-in fees. Drop-in fees incurred are billed the following month.

THERE IS A PROCESSING FEE OF 2.99% ON DEBIT OR CREDIT CARD PAYMENTS.
